OBJECTIVES AND INVESTMENT POLICY

Investment Objective

The Fund aims to provide capital growth over the long term.

Investment Policy

The Fund will seek to achieve its objective through investments in a portfolio of international equity-based securities, collective investment schemes, bonds, cash and money market instruments. Collective investment schemes enable a number of investors to pool their assets and invest in a professionally managed portfolio of investments, typically gilts, bonds and quoted equities.

The portfolio will, in the main, be derived from the Investment Manager's model portfolio, as provided to shareholders with the Reports and Accounts for the Company and as amended from time to time, for a sterling-based international fund which seeks to achieve long term capital appreciation.

The impact of potential currency movements on the sterling value of capital are taken into account when investments are selected.

The Fund has some discretion to invest in a range of investments as described above with no need to adhere to a particular benchmark.

Derivatives may be used for investment purposes and to manage the risk profile of the fund.

Benchmark

The Fund is managed without reference to any target benchmark.

Income

Any income the Fund generates in respect of your investment is rolled up (accumulated) and included in the value of your shares.

Fund Currency

The base currency of the Fund is GBP.

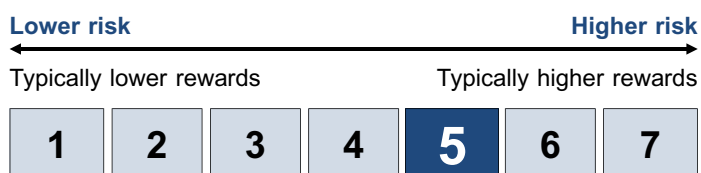
Investment Horizon

Why is the fund in the specific category?

This Fund is ranked at 5 because funds of this type have experienced medium to high rises and falls in value in the past.

The indicator does not take into account the following risks of investing in this Fund:

Interest Rate Risk: Fixed interest securities are affected by trends in interest rates and inflation. If interest rates go up the value of capital may fall and vice versa. Inflation will also decrease the real value of capital.

Counterparty Risk: As the Fund may enter into structured products agreements there is a risk that other parties may fail to meet their obligations. This may lead to delays in receiving amounts due to the fund, receiving less than is due or receiving nothing.

Currency Risk: As the Fund invests in overseas securities movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.

Financial Techniques Impact: The Fund may invest in derivatives. A relatively small movement in the derivative's underlying investment may have a much larger impact, positive or negative, on the value of the fund than if the fund were to hold the underlying investment itself.

Emerging Markets Risk: The Fund invests in some assets which have exposure to emerging market companies. These tend to be more susceptible to large short term swings than shares in more established markets.

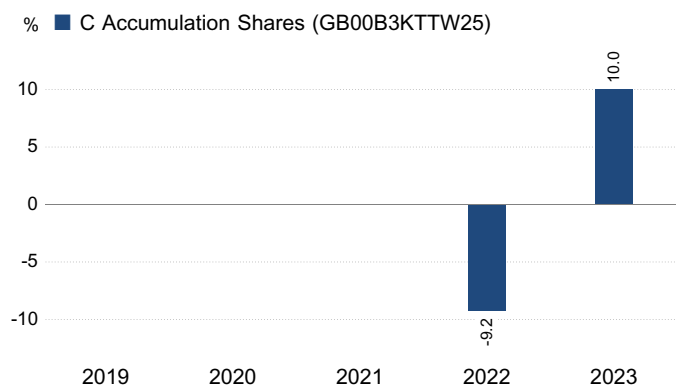
