Objectives and investment policy

Objective:

The Fund aims to provide capital growth over the long term.

Investment policy:

The Fund invests in a range of assets consisting of UK and global company shares, collective investment schemes and bonds issued by governments and companies which are investments similar to loans paying interest over a fixed period of time. Collective investment schemes enable a number of investors to pool their assets and invest in a professionally managed portfolio of investments, typically gilts, bonds and quoted equities.

The Fund has some discretion to invest in a range of investments as described above with no need to adhere to a particular benchmark.

Derivatives may be used for investment purposes and to manage the risk profile of the fund.

Other information:

The Fund aims to distribute available income every year.

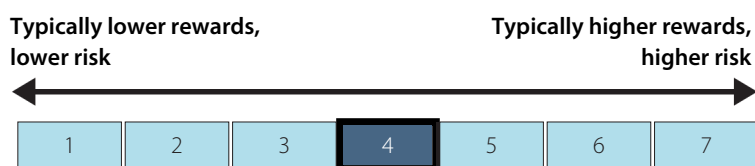

Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area in the table below shows the Fund's ranking on the Risk and Reward Indicator.



The Fund is ranked 4 because funds of this type have experienced average rises and falls in value in the past. Please note that even the lowest risk class can lose you money and that extreme market circumstances can mean you suffer severe losses in all cases. The risk and reward profile is not guaranteed to remain the same and may shift over time. The indicator does not take into account the following risks of investing in this Fund:

Interest Rate Risk: Fixed interest securities are affected by trends in interest rates and inflation. If interest rates go up the value of capital may fall and vice versa. Inflation will also decrease the real value of capital.

Counterparty Risk: As the Fund may enter into structured products agreements there is a risk that other parties may fail to meet their obligations. This may lead to delays in receiving amounts due to the fund, receiving less than is due or receiving nothing.

Currency Risk: As the Fund invests in overseas securities movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.

Financial Techniques Impact: The Fund may invest in derivatives. A relatively small movement in the derivative's underlying investment may have a much larger impact, positive or negative, on the value of the fund than if the fund were to hold the underlying investment itself.

Emerging Markets Risk: The Fund invests in some assets which have exposure to emerging market companies. These tend to be more susceptible to large short term swings than shares in more established markets.

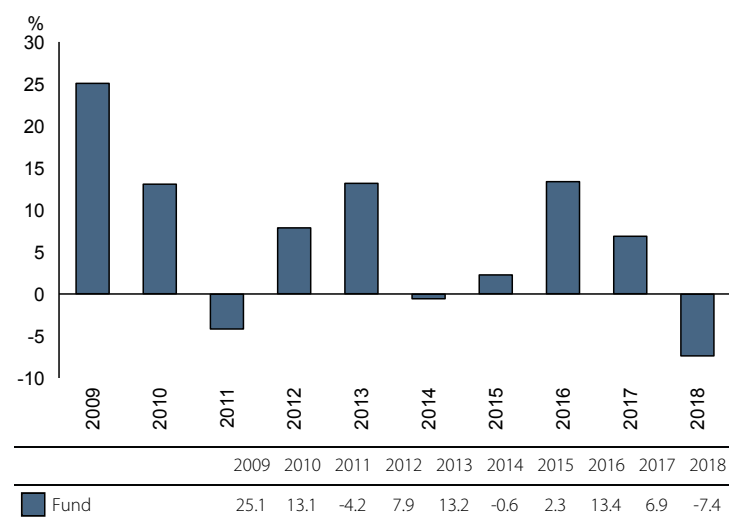
